## NOTICE TO STUDENTS

Please be reminded that, as stated in Article 3 "Benefits and Services to be awarded" of the Call for Applications – Right to Education 2021/2022,

### **THE UNIVERSITY RESIDENCE HALLS WILL BE CLOSED FROM** **AUGUST 1, 2022 to OCTOBER 1, 2022**

**BY JULY 31, 2022, ALL STUDENTS MUST VACATE THEIR CURRENTLY ASSIGNED ROOM LEAVING IT FREE OF ALL PERSONAL BELONGINGS.**

Students who are currently assigned a room and who may be in a housing emergency condition during the closing period (to be demonstrated at the time of application), may apply for a room also for the months of August and September 2022, at the residence hall(s) that will remain open, as further specified in the form to be submitted for the application.

Only the following students may apply for paid housing placement for the months of August and September 2022:

- beneficiaries of the accommodation service for the academic year 2021/22;
- who have no pending administrative positions/outstanding payments towards DiSCo;
- who qualify as “graduating” students by July 31, 2022. In other words, students who are only missing a maximum of 2 exams and the discussion of the thesis by the aforementioned date;

and who are in a housing emergency condition to be justified with the application.

The cost for accommodation for the residence halls in Rome, should the application be accepted, is:

- € 208 monthly for single room accommodation;
- € 193 monthly for accommodation in a "superior" double room;
- € 179 monthly for accommodation in a double room.



For qualifying Afghani and Ukrainian students, the costs established by the Call for Applications – Right to Education 2021/2022 will be applied.

**THE REQUEST FOR A PAID ACCOMMODATION PLACE CAN ONLY BE MADE BY FILLING OUT AND SIGNING THE APPROPRIATE FORM, TO BE SUBMITTED NO LATER THAN JULY 8, 2022 VIA THE SUPPORT TICKET SYSTEM INCLUDING THE REQUIRED ATTACHMENTS.**

A student, whose application is approved, may take possession of the accommodation assigned to him/her for the summer period only once the payment of the stipulated costs has been carried out and proven. Alternatively, students may with their application authorize DiSCo to withhold the sum due for the summer accommodation service from the outstanding installment for the scholarship.

Any qualifying student while applying for housing in the months of August and/or September must unconditionally accept in the application form, that he/she may be assigned a different room and or residence hall than the one currently assigned.

With the exception of “graduating” students who will be able to stay until their graduation but in any case until no later than March 31, 2023 (subject to prepayment for the additional months!), **all students who benefit from the summer accommodation service in August and/or September 2022 must vacate the assigned room by the end of the month for which proof of payment of the relevant cost has been provided (August 31, 2022 or September 30, 2022) .**
